Time to wake up and realize what is going on in the world people – take control of our minds and ability to reason for ourselves. Citizens belong to companies because they pledged allegiance and are consequently granted rights and privileges in exchange for their citizenship (which is essentially tied to their birth certificates).

People are born free in their country, with human rights, inalienable rights, without having to be granted such rights by anyone – they are our God-given rights. We are all born free, with no commitments or obligations to anyone, we are sovereign human beings. No one can enslave us or force us into bondage of any kind.

Remember that just as Mac Donalds cannot force you to follow their rules and regulations unless you work for Mac Donalds – neither can any other company force you to do so. That would be called slavery and servitude. So think about it – what exactly does the company called SWEDEN KINGDOM OF do to every one of us living in Sweden? ***It is a company that illegally pretends to be the Swedish people's government.***

Get used to these facts and expressions because it is the words that govern our lives in illegal courts, that claim to have authority over us.
